# **Test specification for the Pre-Delegation Testing**

### **Background**

The purpose of the Pre-Delegation Testing (PDT) is to verify that the applicant has met its commitment to establish registry operations in accordance with the technical and operational criteria described in the gTLD Applicant Guidebook (AGB). Each applicant will be required to complete Pre-Delegation Testing as a prerequisite to delegation into the root zone.

#### **Document Structure**

The zip file includes the test specifications for Pre-Delegation Testing including a Master Test Plan and the various detailed test plans. The test specifications for Pre-Delegation Testing use the document structure given in IEEE 829-2008, Standard for Software and System Test Documentation. The overall scope for the Pre-Delegation Testing is described in the Master Test Plan (PDT\_MTP). The actual Test Cases are described in the Test Plans. For the Pre-Delegation Testing the following Test Plans have been prepared; DNS, Whois, EPP, IDN, Data Escrow and Documentation (including self certification documentation).

The Test Cases defined in the Test Plans are based on the requirements in the agreement between the Pre-Delegation Testing Service Provider and ICANN based on the AGB requirements. The Test Plans include references to the AGB, specifications in the Registry Agreement, and relevant RFCs.

The different Test Cases are further described in the Test Case documents, where steps taken to execute the Test Case and information needed to perform the tests are described. The Test Cases belonging to one Test Plan are documented in one or multiple Test Case documents depending on the extent of the area.

## Documentation of the data escrow release process testing

ICANN may also elect to have the Pre-Delegation Testing Service Provider verify the data escrow release process. The Pre-Delegation Testing Service Provider will then validate that the escrow agent, upon a request, can release data within 24 hours. The received data will be validated against the requirements given in the Applicant Guidebook.
