“it is necessary for all of these statements of commitment and objectives to be transformed into binding contractual commitments, subject to compliance oversight by ICANN.”

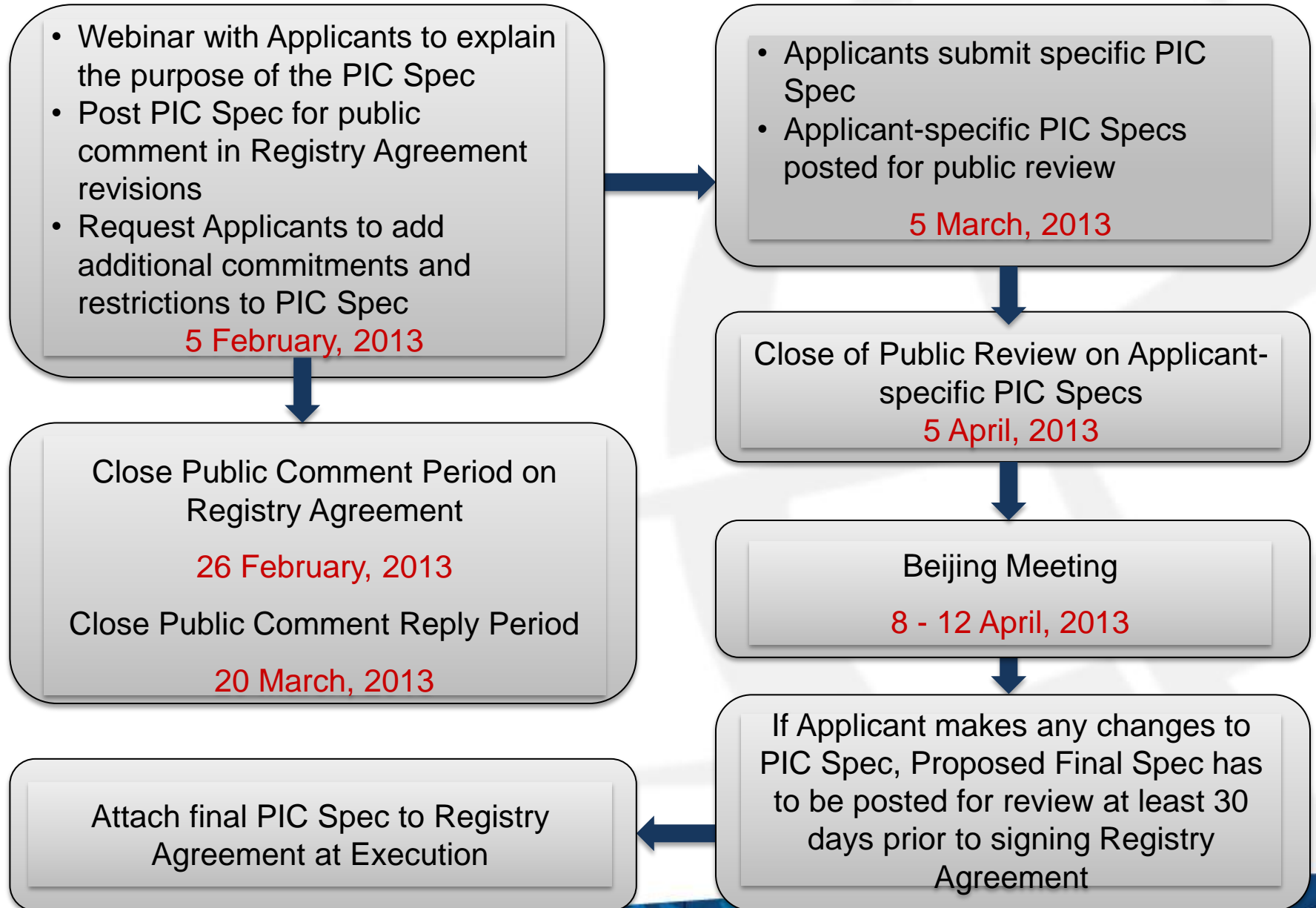
# Proposed Solution

## A New Specification to the Agreement: the Public Interest Commitment (PIC) Spec

1. Obligation to only use registrars under the 2013 RAA
2. Option to designate elements from the application to be included in the agreement
3. Option to spell out commitments to be included in the agreement

# Compliance with PIC Spec

- 3rd parties would be able to use dispute resolution process to address any noncompliance to options 2 and 3 in PIC Spec
- Will be incorporated into the approved dispute resolution procedures for Registry Restrictions (RRDRP) and Post-Delegation (trademark/PDDRP) disputes
- Mandatory conciliation phase will be included

# Key Registry Agreement Changes

**1. Public Interest Commitment Specification (2013 RAA and additional commitments)**

**2. Require implementation of recommendations of the Expert Working Group on gTLD Directory Services if approved by the Board following public comment, so long as implementation is commercially reasonable**

**3. Modify assignment clause to increase flexibility for registries and ICANN and to ensure that ICANN will be able to protect the public interest by making sure that new entities proposing to take over the operation of TLDs will have the necessary background, resources and capabilities**

**4. Allow for amendment of Registry Agreement based upon Board Approval reached after public comment**

# Program Activity Update

- Registry, Financial and Technical & Operational panel CQs started being issued 15-January
  - 95% of first 300 applications have received CQs
  - Some inconsistent CQs have been released due to panel firm differences
  - CSC working to respond to CQ questions within 3 business days
  - Extended CQ response timeframe of four (4) weeks, increased from two (2) weeks, allows for holiday periods around the world
  - Extending CQ response period further would jeopardize existing program schedule

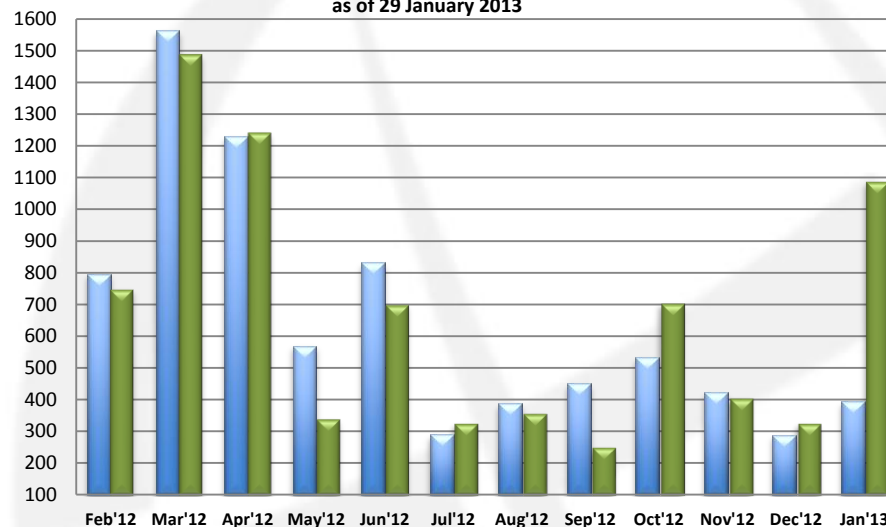

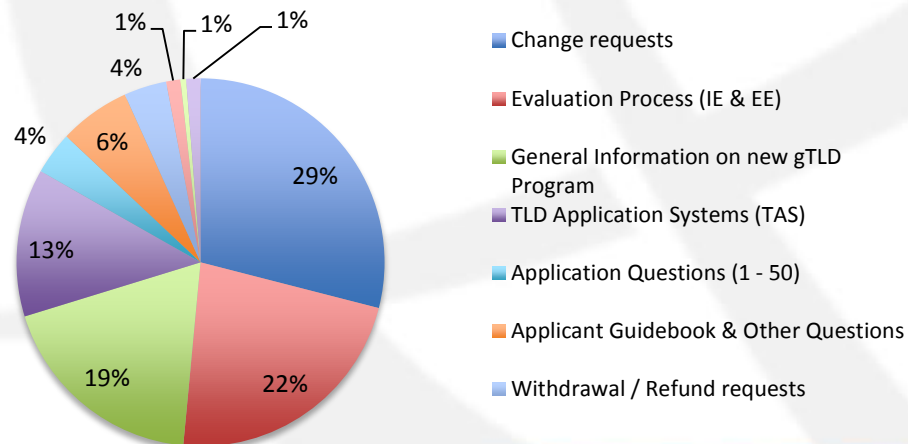
